# Taking Control: The Key to Surviving Life-Threatening Events

This session will discuss the neurological and physiological responses to life-threatening events, likely perceptual distortions, and methods for overcoming these obstacles. Additionally, an evidence-based active shooter protocol developed by the speaker will be provided, as well as important physical security measures and emergency medical procedures likely to be needed in such an event.

# **Emergency Scenario Table Top Exercise Role Play Session**

As school leaders we are expected to be prepared in a school-related emergency situation. Every county in America has a FEMA-affiliated Local Emergency Management Office. These LEMOs typically organize regular table top exercises to help regional service providers practice coordinating with local emergency services during a crisis situation. Schools and districts should be hosting routine table top exercises with their LEMO in order to help building leaders think through how emergency plans will actualize in a crisis situation. These exercises are a powerful way to pull the emergency plan in your school off the shelf and see how it may need to be updated to better prepare your school for a live action and full scale drill involving police, EMS, and other providers. In this session participants will have the opportunity to roleplay and/or observe how a guided table top exercise is conducted.

This session will give participants a thorough understanding of Restorative Practices principles, and upon completion, participants will have a jump-off point to begin implementing RP in their school/district.

# **Human Trafficking Panel**

This presentation will focus on human trafficking and the types of immigration benefits that may be available to survivors of human trafficking who are noncitizens. We will walk through the federal definition of both commercial sex trafficking and labor trafficking. We will explain the requirements for T Visa, U Visa, VAWA, and SIJS which survivors of trafficking are commonly also eligible for using examples to highlight the complexity of these cases. We will also discuss how applying for these immigration benefits is a pathway to a work permit, social security number, Medicaid, and Lawful Permanent Residency. Lastly, we will provide information on the services offered at our organizations to support victims of human trafficking.

After the initial response to a critical incident is over and there is no longer a threat to students and staff, it is the responsibility of the school district to get students back to their loved ones in a safe and accountable manner. Most schools spend a lot of time planning and practicing responding to a critical incident. However, very little thought is given to recovering from an incident. Although, statistically, an active shooter event is over in under 5 minutes, recovery from such an event is interminable. How a school community plans for and executes a family reunification process will determine how quickly and effectively the community will start its healing process. In this session, attendees will learn why a thoroughly planned family reunification process is important, what roles and responsibilities may be required, and who should be involved in the development and deployment of the process. Examples will be shared during this session so that attendees can see components that must be considered when building a process that will work for their individual school community and resource availability.

# Kentucky Office of the State School Security Marshal

#### Ben Wilcox-Day Two-3:00-5:00-Sierra Blanca

This session will cover the passing of the School Safety and Resiliency Act (SSRA) of 2019 and the creation of the Kentucky Office of the State School Security Marshal. The SSRA requires schools to fulfill access control mandates, adding school resource officers and counselors to each school and working towards enhanced mental health care for our students. The Office of the State School Security Marshal performs required onsite assessments of every public school in the state along with assisting districts with school safety issues. This session will also cover the statewide implementation of the Handle With Care program.

Schools play a critical role in crisis prevention and response, meeting not just the needs of students but also of staff, families, and often the local community. Indeed, as evidenced by crisis events over the past decade, schools are integral to an overall community crisis response in terms of providing a safe haven, disseminating information, identifying individuals at risk, providing mental health services, linking individuals with community services, tracking displaced families, supporting long-term recovery, and generally serving as a focus of normalcy in the face of trauma.

To serve this function, schools must have crisis plans and teams in place that encompass preparedness, prevention, response and recovery, both short- and long-term. School safety and crisis teams must be adequately trained in terms of types of crises, systems, procedures, and the unique mental health needs that can arise as the result of a crisis. Plans also must be fully integrated into community emergency response efforts, including public safety, fire and rescue, and community health and mental service providers, as well as clearly communicated to staff, parents, and community leaders.

#### Embedded in all of these issues are:

- the mental health, risk/resiliency, and coping capacity of the individuals affected by crises, particularly students
- the unique opportunities and challenges presented by schools in preventing and responding to crises As such, training for school safety and crisis teams must address crisis as a mental health as well as physical health and safety risk within the context of the school culture.
